Both the parties intended to record the terms and conditions of the Memorandum of Understanding in writing.

Now this Memorandum of Understanding witnessed that in consideration of the mutual covenant contained herein, the parties have agreed as follows:

Period of Memorandum of Understanding:

This Memorandum of Understanding is valid for a period of 12 months from the date it is signed by authorized representatives from both the parties.

Statement of mutual intention:

First Party and Second Party hereby confirm their mutual intention to work together and co-operate with each other.

- The professional fee for the training is **Rs. 1000**/- (One thousand only) per student for a total of 42 hours of training. The minimum number of participating students for the training programme is 50, comprising of First Year MBA students of **DSATM.** If additional students participate then the same will be communicated to the Principal before for invoice generation.
- The above-mentioned price is exclusive of GST i.e. 18%.
- The professional fee for the training should be paid as and when the training is completed (within 10 days).

Time table for the training will be created as per the mutual contrinciple of both the parties (6 hours per resource person of the First party for example of the second party).
