1. PREAMBLE


Emind Technologies helps the students enhancing their knowledge in new technologies through workshop, seminars, projects and placement activities.

- Organize professional activities like workshop, seminar, placement activities, pre- placement training, in house and summer/winter training at campus.
- Student project assistance.
- Provide platform for students for research and consultancy work at their premises or in industries.
