




To provide a skill building platform and networking with industry professionals whereas GWFM will run multiple employability enhancement programs through monthly events at the college based on a planned calendar. GWFM & Dayananda Sagar Academy of Technology and Management shall work hand in hand as a single team to plan and execute the programs for entire year through:

1. Monthly Meet-ups
2. Students assessment & Feedback
3. Depending on suitability and capability the students would be bucketed for various levels of jobs.
4. Training regimen would be implemented to enhance capability
5. Periodic Assessment would be conducted to track improvements and effectiveness.
6. Students mapping to industry segments and stream
7. Customised programs based on the industry needs
8. Activity based learning with gamification and innovation capability building
9. Creating employability prospects for the students
10. The final semester students would be evaluated separately through intervention activities at a cost. The activities include - job specific training programs and thereafter employment opportunities may also be provided (offsite/ onsite).

General terms and Conditions:

- a) This MOU shall be effective from the date of affixture of signatures of the parties and will remain in force for a period of one year and two months.
- b) All activities are based on the Student Membership Charges.
- c) Dayananda Sagar Academy of Technology and Management will ensure the membership of students to be included in the Student Chapter at per student charge of Rs 1000/-
- d) There are costs involved in each activity which will be communicated as and when it is executed and the activity will be initiated once both parties agree.
- e) This MOU will be renewed by the partnership committee members from time to time and may be amended with the consent of both the parties and thereafter confirmed in writing.
- f) The parties agree and acknowledge that no other rights are granted except as explicitly stated herein.
- g) Neither party shall transfer or assign its interest, obligations, or rights in this agreement without the written consent of the parties, provided that such consent will not be not be unreasonably withheld.
- h) Any other arrangements or activities or commitments shall be made only on mutually agreed terms from time to time.

Tenure and terminations:

For GLOBAL WFM NETWORK FORUM

- i) This agreement shall commence from the date of agreement and shall continue in force for one year and two months until terminated by either party.
- j) Either party may terminate on this agreement upon prior notice to the other party, which will however be subject to compliance to completion of all commitments made.
- k) Notwithstanding any such termination, both parties shall ensure that all activities in progress are completed successfully.
- l) Payment shall be transferred to GWFM TRUST account in advance
- m) Student's membership will not be transferable to others
- n) Dayananda Sagar Academy of Technology and Management should pay for the industry guests transport (Pick-up and drop or Taxi chargers or their fuel cost if they come on their own vehicle) from outside the city if required.

TENURE AND TERMINATION:


This agreement shall commence from the date of agreement and shall continue in force for one year until terminated by either party.


