## MEMORANDUM OF UNDERSTANDING (MoU)

### II. Terms of MoU

The terms of collaboration for each activity executed under this MoU shall be jointly deliberated and agreed upon in writing by both the Institutions prior to the initiation of that activity. Any such MoUs entered into, as charted above, will form appendages to this MoU for Cooperation.

The partnering Institutions hereby agree upon the following terms to establish the Exchange Program and to execute other aforesaid activities

1. The aim of the faculty exchange program is to provide students an opportunity to learn and gain insights from the faculty members of both the institutions and also to boost the morale of the faculty members by enabling them to deliver curriculum in diverse learning environment.
2. The two institutions will actively seek to promote mutual faculty exchange for agreed upon periods.
3. Faculty exchange may assume various forms, such as individual short-term and long-term visits of faculties or participation in seminars, conferences or academic activities.
4. The host institution shall be responsible to ensure payment of honorarium to the faculty members of the home institutions engaged in exchange program and facilitate them with all the essential resources to conduct classes using online platforms or class room sessions to the students of the host Institution.
5. The exchange of faculty will be subject to the rules at the host institution, while on exchange.
6. Exchange of faculty members will be pertinent to their field of expertise.
7. The feedback and achievement if any attained by the faculty members herein during the exchange shall be communicated to the home Institution.
8. Any Intellectual Property developed during the joint activity will be owned by both the Institutions.

### II. Exchange of Information

- Information pertaining to the courses delivered by Institution faculty members in the host Institutions will be actively exchanged with the students.

### III. Terms of Implementation, Renewal, Revision, Cancellation and Notices

3. This MoU will be renewed after five years upon the consent in writing of both institutions. Each Institution may cancel the MoU by notifying the other Institute of its intent to do so at least a month in advance of its expiration. Projects in progress at the time of termination will remain unaffected.
4. Any amendment or modification to the present text shall be submitted for review to the competent authorities and shall not be binding unless reduced to writing and signed by both the Institutions.
