BETWEEN

AND

Vyakti Vikas Kendra India (VVKI), having its office at The Art of Living International center, 21st KM Kanakapura main road, Udayapura, Bangalore 560082 (hereinafter referred to as "Service Provider") which expression shall unless repugnant to the context or meaning thereof mean and include her successors and permitted assigns; represented by **Shri Suresh Babu B (Trustee)**

(Subscriber and the Service Provider are hereinafter collectively referred to as Parties and individually as Party, as the context may demand)

WHEREAS:

1. Subscriber is an academic and research Institute

This agreement can be extended for such further period as may be agreed mutually by the above mentioned parties after the above mentioned period.


2. Scope of Services:

- ii. The program payment shall be credited to the service provider's account by the subscriber against the invoice raised, before the commencement of the program.

4. Representation and Warranties by the Service Provider:

- (i) The Service Provider hereby represents and warrants that she and her team will provide the Subscriber with specific services at a high professional quality standard and in a responsive manner.
- (ii) Service Provider acknowledges and understands the obligation to maintain the confidentiality and integrity of any information received under this Agreement, which is otherwise not available with public domain.
- (iii) Service Provider and her personnel agree and undertake to keep confidential at all times, all information which Subscriber may provide to the service provider or its personnel.
- (iv) All information exchanged between the parties to this agreement is for exclusive use for the verification purpose of the applicant and the service provider shall take responsible steps to ensure that all information provided by the subscriber shall be protected, kept confidential and shall not be disclosed to any third party.

5. Confidentiality:

The Service Provider may receive information proprietary from the Subscriber (the "Confidential Information") in the course of performance of its obligations under this AGREEMENT. The Service Provider understands and acknowledges that the information is valuable and confidential and agrees that it will at all times be kept in trust and not to be disclosed without prior written permission from the Subscriber.

8. Governing Law and Jurisdiction:


The contract shall be governed by and construed in accordance with the laws of India and subject to Bangalore jurisdiction.




