6. The institute will bear all the expenses related to implementing programs, projects and shall pay the applicable service fees to PathfinderNRI as per the payment terms and conditions set.

Miscellaneous Provisions:

1. The Memorandum of Understanding (MoU) as outlined in this document is not intended to be a legally binding document. Rather, it is meant to describe the nature and cooperative intentions of Dayananda Sagar Academy of Technology and Management and PathfinderNRI to suggest guidelines for cooperation. Nothing therefore, shall diminish the full autonomy of either party, nor any constraints be imposed by either party upon each other, and nothing in this agreement shall be deemed to create a partnership, joint venture, or agency relationship between the parties.
2. The use of the name, logo and/or official emblem of any of the parties on any publication, document and/or paper is allowed only after seeking explicit prior permission in writing by either party.
3. The MoU or any part thereof may be amended at any time during its tenure only by consent in writing of the parties.


