



MEMORANDUM OF UNDERSTANDING (MOU)

1. Objectives of the MOU

The objectives of the MOU are:

- b) To conduct innovative events, tech talks, workshops and Hackathons at Dayananda Sagar Academy of Technology and Management.
- c) To guide for setting up of Innovation labs for helping students in their projects.

2. Technical Areas of Collaboration

- a) Cyber Security and Ethical Hacking
- b) Internet of things
- c) App Development for IoT applications.

3. Proposed Modes of Collaboration

Reverse Engineering InfoSec Pvt Ltd and Dayananda Sagar Academy of Technology and Management propose to collaborate through the following:

- Conduct Technical training and workshops on Cyber security, Internet of Things, Arduino and Raspberry Pi basics and Android App Development.
- b) Any other appropriate mode of interaction agreed upon between Reverse Engineering InfoSec Pvt Ltd and Dayananda Sagar Academy of Technology and Management.

A specific plan will be worked out by the institutes depending upon the availability of resources. A specific agreement will be entered into for each activity.

4. Terms and Conditions

- a) The cost of development of infrastructure and maintenance at Dayananda Sagar Academy of Technology and Management should be borne by Dayananda Sagar Academy of Technology and Management.
- b) Reverse Engineering InfoSec Pvt Ltd shall only act as training partner for the Innovation Lab, Marketing and admission of students for events to be conducted from Reverse Engineering InfoSec Pvt Ltd will be handled by College.
- c) The event shall not be conducted unless interested crowd to attend is minimum of 80 for all the events.
- d) Reverse Engineering InfoSec Pvt Ltd shall not bear resources cost like hardware, software etc. and damage / maintenance of any during the course of event shall be borne by the college.
- e) The schedule of event planned should be notified 2 weeks prior to Reverse Engineering InfoSec Pvt Ltd and event shall be conducted only after the availability of resource person is confirmed.
- f) The charges per event may vary depending on the crowd, Duration of event and

- g) The payment to Reverse Engineering InfoSec Pvt Ltd should be done within one week after the event is conducted and payments have to be made to Reverse Engineering InfoSec Pvt Ltd bank account only irrespective of the trainer.
- h) Registration fees for the events in the domain of Reverse Engineering InfoSec Pvt Ltd shall be decided by college on consultation with Reverse Engineering InfoSec Pvt Ltd before the event.
- i) Once agreed, it will be the sole responsibility of Reverse Engineering InfoSec Pvt Ltd to complete the event successfully.
- j) The training will be conducted to the registered candidates only; Reverse Engineering InfoSec Pvt Ltd has rights to verify the candidates list and shall not train to extra candidates or faculty who has not paid /registered.
- k) The payments are excluding tax, TA and DA. TA and DA (if demanded by the resource person only).
- I) The cost of procuring and installing the hardware / software will be charged excluding the hardware/ software cost.
- m) College is responsible to maintain the transparency in context of fees / payments between students and Reverse Engineering InfoSec Pvt Ltd.
- n) This MOU may be amended, renewed and terminated by mutual written agreement of the institutes at any time.
- o) Either institute shall have the right to terminate this MOU upon 60 days prior written notice to the other institute.

5. Confidentiality

a) Reverse Engineering InfoSec Pvt Ltd and Dayananda Sagar Academy of Technology and Management agree to hold in confidence all information/data designated by the institutes as being confidential which is obtained from either institute or created

6. Duration of MOU

This MOU, unless extended by mutual written consent of the institutes, shall expire in Two years after the effective data specified in the opening paragraph. However, on review, the MOU shall be extended or modified by mutual consent.

7. Coordinators

Both Institutes will designate persons who will have responsibility for Co-ordination and implementation of this agreement.
