Neither party shall be liable for any special, indirect, incidental, punitive,






contingent nor consequential loss or damages suffered out of or in connection with the aforesaid MOU whether as a result of a breach of this MOU or otherwise.

**1<sup>st</sup> phase:** Students will be given assistance from our company professionals who are experts in the platform of coding and designing.


